In accordance with Governor Abbott’s Executive Order or Proclamation dated March 13, 2020 and continued by monthly Executive Orders or Proclamations to the most recent Proclamation dated May 5, 2021 relating to the COVID-19 pandemic and the need to minimize face-to-face contact, the City of Hedwig Village held the May 12, 2021 City Council Meeting in person with several participants joining the meeting via Zoom, as noted below.
