## 2. PLEDGE OF ALLEGIANCE

Mayor Jinks led the City Council, Planning & Zoning Commission, City staff, and visitors in the Pledge of Allegiance.

#### 3. CITIZEN/VISITOR COMMENTS

Andrea Hermann, 930 Karos Lane, commented on vacant lots throughout the City on which all trees have been removed.

#### 4. DISCUSSION REGARDING THE DRAFT COMMERCIAL DESIGN GUIDE

Planning & Zoning (P&Z) Chair Peter Sanborn stated the intent of the design guide is to create a vision for the business districts within the City and to increase redevelopment and spur pedestrian amenities in the commercial districts.

Councilmembers and Planning & Zoning (P&Z) members reviewed and discussed several topics in the draft commercial design guide. The topics discussed included:

- Site planning to promote active and attractive street-fronts free of large unbroken parking lots and visible service areas.
- Building orientation to promote active, street-facing buildings and conceal loading and service areas.

- Cross-Access easements to reduce traffic exiting from parking lots onto main roadway network, ease pedestrian movement and to encourage shared parking by requiring through-block access on large lots.
- Landscaping to create a unified tree canopy and "green space" along Gaylord Drive and institute stronger interior-site landscaping throughout the commercial districts.
- Pedestrian accommodations to improve pedestrian accessibility and pedestrian experience on commercial sites and at the interface of commercial and residential zones.
- Refuse containers to provide adequate refuse services on site, while reducing their visibility.

Councilmember Rouse expressed concern that some topics in the draft design guide should be guidelines, not changes to an existing ordinance.

Councilmembers and P&Z members discussed adding definitions for several terms mentioned in the draft design guide.

Councilmembers and P&Z members discussed which topics should be a change to existing ordinances or be a guideline.

Marsha Doyle, Kendig Keast, and Greg Filsram, Kendig Keast, attended the workshop via Zoom to answer questions and to revise the draft design guide based on comments.

#### 5. ADJOURN

Motion was made by Councilmember Rouse and seconded by Councilmember Trozzo to adjourn the meeting at 8:06 p.m. Motion carried 4-0.
