2. PLEDGE OF ALLEGIANCE

4. DISCUSSION AND POSSIBLE ACTION REGARDING THE DRAFT COMMERCIAL DESIGN GUIDE

Councilmembers and Planning & Zoning (P&Z) members reviewed and discussed several topics in the draft commercial design guide. The topics discussed included:

- Building Entry Orientation and Design to clearly establish a main building entry and offer a secondary entry point to connect pedestrians to the promenade.
- Building Modulation and Design guidelines for visual interest of buildings, architectural elements, and facades.
- Parking Structure Design to reduce the visual obtrusiveness and deadening effect of large parking structures.

- Lighting to create a cohesive lighting look across the commercial districts that contributes to a safe and aesthetically pleasing environment to prevent light spill onto adjacent properties.
- Parking Lot Standards to break-up and conceal parking areas. This topic includes surface parking location/placement, parking requirements, and parking lot landscaping.
- Applicability to clarify when the design standards are required.

Councilmembers and Planning and Zoning Members discussed which topics in the design guide should be changes to existing ordinances or remain as guidelines.

Councilmember Rouse expressed concern regarding the proposed changes to the existing parking requirements and the placement of parking garages at the center of the site.

Marcia Doyle, Kendig Keast, attended the workshop via Zoom to answer questions and to revise the draft design guide based on comments.
