2. PUBLIC HEARING

A. The purpose of the public hearing is to receive and consider public input and comments, either oral or written, regarding amending the Hedwig Village Planning and Zoning Code to prohibit drive-through facilities in all Business Districts of the Citv.

Andrea Hermann, 930 Karos Lane, asked if the prohibition limits drive through for banks.

P&Z Chair Sanborn explained the purpose of the prohibition. Currently, the City allows drive-through facilities in Business District B4 and only on corner lots with a few other restrictions. The prohibition would apply to all drive-through facilities. He stated the City currently has a few drive-through facilities that restrict traffic flow on streets.

Ralph Kerr, 11747 Duart Drive, encouraged Council and P&Z to not be overly broad in the drive through restriction, to be specific in the language. He stated this prohibition might discourage businesses from moving into Hedwig Village.

John Irwin, P&Z Member, asked if the proposed change to the Code would affect existing drive-through facilities.

The existing drive-through facilities will be "grandfathered" in the Code.
