- A. Sec. 38-84. Stormwater detention- Discussion
  - Single Family lots- new construction single family lots are not required to provide stormwater detention
  - Commercial Lots-
    - 1. TXDOT right of way drainage requirements
    - 2. Redeveloped lots with drainage infrastructure requirements
    - 3. Requirements of existing commercial lots abandoned for more than 4 yrs with no buildings or maintained drainage infrastructure need to provide the greater of the volume determination below for stormwater detention
  - Runoff Determination- Discussion
    - 1. Stormwater runoff calculations
    - 2. The rational method used for stormwater calculations,
    - 3. Harris County infrastructure regulations
    - 4. Design stormwater detention calculations
