

**RESOLUTION NO. 05-08-25A**

**A RESOLUTION CREATING HEALTH INSPECTION, FOOD SERVICE, AND RELATED SERVICES FEES FOR ESTABLISHMENTS WITHIN THE CITY OF HEDWIG VILLAGE, TEXAS; REPEALING ALL OR PARTS OF OTHER FEE SCHEDULES INCONSISTENT OR IN CONFLICT HEREWITH.**

**WHEREAS**, the City of Hedwig Village, Texas requires health inspections, food service, and related services inspection for all establishments serving or preparing food within the City limits, and;

**WHEREAS**, it is reasonable to adopt fees for such inspections in order to recoup the costs to the City.

**NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HEDWIG VILLAGE, TEXAS:**

**Section 1.** That the recitals set forth above are found to be true and correct.

**Section 2.** That there is hereby created and established a Schedule of Food Services Fees for Health Inspections, Plan Reviews and Food Services, a copy of which is attached hereto as Exhibit "A" and made a part hereof for all purposes.

**Section 3.** That any person or establishment who operates, prepares, or serves food shall pay the fee as stipulated in the Food Services Fee schedule.

**Section 4.** That the City Staff are hereby authorized and required to collect the fees as set forth on the attached Exhibit "A", and to pay the same into the treasury of the City.

**Section 5.** In the event any clause, phrase, provision, sentence or part of this Resolution, or the application of the same to any person or circumstance, shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair or invalidate this Resolution as a whole or any part or provision thereof, other than that part declared to be invalid or unconstitutional; and the City Council of City of Hedwig Village, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any such part thus declared to be invalid or unconstitutional whether there be one or more parts.

**Section 6.** That this resolution shall be published and shall become effective in accordance with state law.
