## **RESOLUTION NO. 08-11-22D**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF HEDWIG VILLAGE, TEXAS, AMENDING THE SCHEDULE FOR CONTRACTOR'S REGISTRATION, BUILDING AND CONSTRUCTION FEES FOR COMMERCIAL AND MULTI-FAMILY PROJECTS AND REPEALING ALL OR PARTS OF OTHER FEE SCHEDULES INCONSISTENT OR IN CONFLICT HEREWITH.

WHEREAS, the City of Hedwig Village, Texas (the "City") requires permits for all commercial building and construction projects within the City limits; and,

WHEREAS, the review of commercial construction projects warrants the establishment of a commercial/multi-family permit fee structure commensurate with the complexity of the construction project; and,

WHEREAS, the City Council of the City of Hedwig Village, Texas (the "City Council") has previously adopted a Schedule for Contractor's Registration, Building and Construction Fees for Commercial and Multi-Family Projects consistent with the requirements of Section 214.907 of the Texas Local Government Code; and,

WHEREAS, the City Council has determined that the Schedule for Contractor's Registration, Building and Construction Fees for Commercial and Multi-Family Projects should be amended.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF HEDWIG VILLAGE, TEXAS:

**Section 1.** That the recitals set forth above are found to be true and correct.

Section 2. That the Schedule for Contractor's Registration, Building and Construction Fees for Commercial and Multi-Family Projects of the City is hereby amended

and restated to read as attached hereto as Exhibit "A" and made a part hereof for all purposes.

Section 3. That any person who commences work on any building and

construction project before obtaining the necessary permits shall be subject to an additional

fee that shall be paid in addition to the required permit fee.

Section 4. That the City's Permitting Department is hereby authorized and

required to collect the amended fees as set forth on the attached Exhibit "A", and to pay the

same into the treasury of the City.

Section 5. That in the event any clause, phrase, provision, sentence or part of this

Resolution, or the application of the same to any person or circumstance, shall for any reason

be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not

affect, impair or invalidate this Resolution as a whole or any part or provision thereof, other

than that part declared to be invalid or unconstitutional; and the City Council of City of

Hedwig Village, Texas, declares that it would have passed each and every part of the same

notwithstanding the omission of any such part thus declared to be invalid or unconstitutional

whether there be one or more parts.

Section 6. That this resolution shall be published in accordance with the requirements

of state law and shall become effective January 1, 2023.
